Prior to becoming a trustee, Yarbrough taught economics at both of the district's colleges, Santa Ana College and Santiago Canyon College. He has served as an executive board member of Mothers Against Drunk Driving and on the board of the Orange County Chapter of the American Lung Association. He has also served as Orange County coordinator of The Concord Coalition, a non-profit organization dedicated to eliminating federal deficit spending and balancing the federal budget. He holds a bachelor's degree in manufacturing/industrial engineering from Syracuse University and master's degrees in operations research and business management from the Rochester Institute of Technology. He is also a nationally certified Supply Chain Management Professional.

Barrios was appointed to the Board in 2011 to fill a vacant trustee position for Trustee Area Three. She is a resident of Orange and a marketing and communications consultant with over 20 years experience with educational, non-profit and for-profit organizations. As the owner of Barrios & Associates, she has served as a communications consultant for several school districts, including the Compton Unified School District during its reorganization in the 1990s.
