1.0 PROCEDURAL MATTERS

1.1 Call to Order

2.0 GENERAL

2.1 <u>Status of H.R. 242 (Sanchez) – The Affordability for Constant and Continual</u> Education to Enhance Student Success Act

The committee discussed the status of H.R. 242 (Sanchez) – The Affordability for Constant and Continual Education to Enhance Student Success Act and made the recommendation to support the bill.

2.2 Review of AB 288 (Holden) – The College and Career Access Pathways Act

The committee reviewed AB 288 (Holden) – the College and Career Access Pathways Act and made the recommendation to support the bill.

2.3 <u>Review of AB 963 (Bonilla) – Protecting CalSTRS Membership and Retiree Service</u> <u>Time</u>

The committee reviewed AB 963 (Bonilla) – Protecting CalSTRS Membership and Retiree Service Time and made the recommendation to support the bill.

Dr. Rodríguez arrived at 5:22 p.m. during the discussion of Item 2.3.

Mr. Hanna asked that Item 2.4 be discussed after Ms. Alvarez arrived.

2.4 <u>Status of AB 1468 (Baker) – Disability Access</u>

The committee discussed AB 1468 (Baker) – Disability Access and made the recommendation to support the bill. Mr. Hanna asked the chancellor to encourage other districts to support this bill. Ms. Alvarez asked TPA staff to develop a new strategy to move the bill forward.

2.6 Review of 2015-2016 Legislative Matrix

Since the legislative matrix was 30 pages, the committee asked if any bills stood out to review. The committee discussed a few bills and asked the chancellor to review the list and advise the board of his recommendations. Mr. Hanna asked that bills relating to assisting students or statewide bonds be brought to the committee's attention.

Ms. Fernandez provided a brief update on Item 2.1 (H.R. 242 [Sanchez]) to Ms. Alvarez at this time per Ms. Alvarez' request.

Mr. Hanna left the meeting at 6:05 p.m.

Ms. Alvarez noted the request made by Mr. Hanna in Item 2.6 regarding the legislative matrix. The chancellor suggested an update on the status of AB 1468 (Baker) – Disability Access be included on a future agenda.
