1.0 PROCEDURAL MATTERS

1.1 Call to Order

The meeting was called to order at 4:34 p.m. by Ms. Claudia Alvarez. Other member present: Mr. Zeke Hernandez.

Others present: Mr. Casey Elliott (Townsend Public Affairs [TPA], Sacramento), Ms. Chelsea Vongehr (TPA), Mr. Enrique Perez, Dr. Raúl Rodríguez, Ms. Monica Zarske, Mr. Juan Esqueda, and Ms. Anita Lucarelli as record keeper. Ms. Laura Kroeger (TPA, Washington, D.C.) was present via teleconference.

1.2 Pledge of Allegiance to the United States Flag

The Pledge of Allegiance was led by Ms. Zarske.

1.3 Public Comment

There were no public comments.

1.4 Approval of Minutes

2.1 Review of Assembly Bill (AB) 847 – Academic Senates: Membership

The committee discussed AB 847 – Academic Senates: Membership. Ms. Zarske shared the Academic Senate's concerns regarding the bill from Mr. Michael DeCarbo's email as follows:

The faculty are in favor of diversity, but they are not in favor of this bill and respectfully request that we not pursue supporting it.

2.1 Review of Assembly Bill (AB) 847 – Academic Senates: Membership (cont.)

In light of recent attacks on academic freedom and the personal privacy of professors (i.e. http://www.professorwatchlist.org/) the faculty do not see that it is necessary for their demographic information to be made public.

Some of our Senators are not tenured; they express concern that they would not feel safe to express ideas for fear of recrimination.

Some of our Senators might be labeled terrorist for their religious beliefs.

Some of our Senators voiced concern that it may lead to mandating that senate bodies reflect demographics.

The State already collects demographic data on the faculty; we do not feel that it is necessary to also collect it at this micro-level for the concerns above.

The Academic Senate of California Community College's passed a resolution in opposition to AB 847 that all three of the RSCCD Senate representatives voted in favor of supporting.

Ms. Alvarez asked that this item be placed on the next committee meeting's agenda for further discussion.

2.2 Review of Legislation to Establish a Secure Program for Deferred Action for Childhood Arrivals (DACA) Students

The committee discussed legislation relating to DACA students. The committee asked TPA to provide the chancellor with a letter in support of DACA students and a document that would compare the bills relating to DACA students. She asked that the letter and the document be placed on the agenda for the full board to consider at its October 23, 2017, board meeting. Mr. Hernandez suggested board members meet with the Associated Student Government leaders to explain DACA to the student leaders in order to receive feedback from them.
