2.0 REVIEW OF BOARD POLICIES & RELATED ITEMS

Mr. Labrado arrived during the beginning of discussion of Item 2.1.

2.1 Review of BP 4026 Baccalaureate Degree Programs

The committee reviewed this policy and a lengthy discussion ensued with all attendees. Faculty and classified staff represented voiced their concerns and urged the committee to wait on adopting this policy until further information relating to the implementation of SB 850 (community college pilot baccalaureate degree program) is available.

The student represented indicated that students expressed support of participating in a pilot baccalaureate degree program.

Dr. Rodriguez arrived during the middle of the discussion of Item 2.1.

Administration staff shared Dr. Constance Carroll's (Chancellor, San Diego Community College District) concerns and indicated the two programs under consideration at Rancho Santiago Community College District (RSCCD) are Santa Ana College's welding and automotive programs.

Committee members explained that if the board adopted this policy, it indicates that the board is enabling the chancellor and academic senate to explore the possibility of the RSCCD students participating in a pilot baccalaureate degree program. Therefore, the committee recommended the policy be forwarded to the board for a second reading.

2.2 Review of BP 6610 – Opportunities for Local Hires and Local Businesses on District Capital Improvement and Construction Projects (New)

The committee reviewed this policy, recommended changes, and recommended the policy be forwarded to the board for a first reading.

Mr. Hanna asked that the next Board Policy Committee meeting agenda include an item to ensure the board of trustees annually holds a board meeting on each campus.
