1. PROCEDURAL MATTERS

1.4 Approval of Minutes

2.3 <u>Review of BP 2745 Board Self-Evaluation</u>

Mr. Enrique Perez, Vice Chancellor, Educational Services, reviewed on Board Policy 2745 Board Self-Evaluation. Committee members received clarification on the data related to RSCCD's board self-evaluation tools and discussed how the survey can be updated. Mr. Crockett suggested the evaluation be sent to vendors who the district conducts business with. Mr. Hanna suggested adding questions to the evaluation survey that asks about trustee community involvement. Mr. Hanna also suggested that all the mayors and city council members from the cities we serve, as well as the superintendents from all the school district we serve, should receive an evaluation. Mr. Perez advise committee members that he would present a revised evaluation instrument at a later meeting.
