### **State/District Budget Update**

- No new reduction unless tax fails
  - Community Colleges will be held harmless for any shortfall in redevelopment funds
- If tax fails
  - Potential risk for RSCCD is a reduction of approximately \$8.6 million, will be treated as negative growth of 7.5% workload measure reduction effective 1/1/2013
  - RDA to backfill will not happen
- If property tax and fee revenue falls short, we would have to absorb, there will be no backfill
