Dr. Rodríguez informed the committee of the recent "ransomware" attack at Los Angeles (LA) Valley College where the LA Community College District had to pay hackers \$28,000 to regain access to their electronic information. Ms. Krichmar stated that hackers are very good and ransomware links can have any address attached to it so employees should hover their mouse over the link to view the true address to the link. Ms. Krichmar plans to provide a link to a video explaining what to do/not do with email that appears suspicious. It was suggested that the video be shown to faculty at the beginning of the academic year.

#### 4. Committee Reports

#### a. Planning and Organizational Effectiveness Committee (POEC)

Vice Chair Jaros reported that the last meeting was held on November 30 where discussion took place regarding the Governance Summit and Board Strategic Planning Meeting in February. ## Committee Goals 2016-2017 Fall 2016 Update

The POE Committee has met monthly during fall 2016; all agendas include an item related to one or more of the POE goals in progress. The final meeting was held November 30, 2016. The first meeting in the spring semester will be February 22, 2017.

- Work to align the planning and budget cycles between the colleges and the District.
   This item is ongoing. There is an ongoing agenda item for SAC and SCC planning updates. The resource allocation timelines of SAC and SCC are coordinated with the district timelines through the Planning and Institutional Effectiveness Committee (PIE) at SCC and the Resource Allocation Request process (RAR) overseen by the Planning and Budget Committee at SAC. This alignment needs to be formalized, however.
- 2. Serve as the oversight committee for the RSCCD Mission and Strategic Plan. A workgroup have been developed to create the PowerPoint presentation for the February 27, 2017 Board meeting to present the 2016-2019 RSCCD Strategic Plan. The POE committee has also approved the data points selected by the workgroup to complement the 2016-2019 Strategic Plan Update for the February 2018 meeting of the Board of Trustees. Data will be collected from designated groups/persons in preparation for the Board presentation. This process was presented to District Council and approved.
- 3. Ensure integration of clearer responsibilities between the Fiscal Resources Committee (FRC) and POE utilizing District Council as the designator of responsibilities.

  The chairs of POE and FRC attend District Council; in fall 2016 no issue has arisen regarding committee responsibilities.
- 4. Assist in planning the District Governance Summit.

  The POE committee has created an agenda for the February 7, 2017 governance summit, and the committee will take the lead to oversee the summit on behalf of the Chancellor and District Council.
- 5. Serve as the oversight committee for district-wide grants.

  The Vice Chancellor of Educational Services serves as the chair of POE and presents a grants update at every meeting. All questions and comments are documented in the minutes.
- 6. Inform district governance committees of their respective roles in accreditation so they may serve as a support to the colleges.
  - An accreditation update will be made at the February 7, 2017 governance summit.
