1. Approval of Minutes

The motion to approve the minutes of the March 12, 2014 meeting was moved by Judy Chitlik, seconded by Suzanne Stump. The motion was carried unanimously.

2. Update on Full-time Faculty Recruitment Activities

There are 32 credit positions the district is attempting to fill to comply with the FON by next Fall. Judy Chitlik, Assistant Vice Chancellor Human Resources, reported:

- 3 offers have been made and accepted on the English positions
- Manufacturing Technology, Human Development and Auto Tech are currently in the screening process
- Diesel Technology only 3 people applied, the decision was made to repost to get a larger pool
- All other faculty positions are in the interview process

3. Revised HR Administrative Regulations

The Human Resources committee will be reviewing Administrative Regulations that are being revised and renumbered with a plan to have them completed by the end of summer. AR 3430 Prohibition of Harassment was reviewed and after discussion, it was decided to have the academic senates at Santa Ana College review and comment on the Academic Freedom portion of the administrative regulation. AR 3510 Workplace Violence Plan was also reviewed and a motion to forward AR 3510 to District Council for approval was moved by Morrie Barembaum, seconded by John Zarske. The motion was carried unanimously.
