Chancellor Marvin Martinez convened the meeting at 3:05 p.m.

1. Approval of Minutes of August 26, 2019 Meeting

It was moved by Mr. Hardash, seconded by Mr. DeCarbo and the motion carried unanimously to approve the minutes of the August 26, 2019 meeting.

2. Chancellor's Update

Chancellor Martinez provided an update on the incident at Santa Ana College (SAC) that caused the campus to be closed. Mr. Martinez shared that the incident involved no one associated with SAC and the campus was closed until 5 p.m. to give the Santa Ana Police time to investigate.

An update on AB 48 – Statewide Facilities Bond was provided by Chancellor Martinez. A negotiated compromise will provide \$2 billion to community colleges. The bond will be placed on the March 2020 ballot where it must pass with a two-thirds vote. If passed, the State Chancellor's office will control the dissemination of the bond funds allocated to community colleges and RSCCD may not get any funding. This is why the board is considering a district bond.

2. Chancellor's Update (continued)

Chancellor Martinez also reported that focus on student access to affordable housing is a priority for the OC Community Colleges Legislative Taskforce. The lack of affordable housing has caused families to move out of the area, resulting in a decrease in enrollment.

3. Budget

a. Vice Chancellor Hardash shared there was nothing new to report on the budget and we will continue to monitor the implementation of and any changes to the Student Centered Funding Formula (SCFF).

4. Reorgs

a. Vice Chancellor Enrique Perez announced that Reorg #1155 – DO/Ed Services was being pulled and will be brought back to District Council.

5. Board Policies

- a. BP 4110 – Honorary and Posthumous Degrees and Certificates and
- b. BP 5220 – Shower Access for Homeless Students (NEW) were presented to District Council.

It was moved by Mr. DeCarbo, seconded by Ms. Zarske and the motion carried unanimously to endorse the policies for consideration by the Board Policy Committee.

6. Administrative Regulations

a. AR 5220 – Shower Access for Homeless Students (NEW) was presented to District Council. It was suggested that the AR be taken through the college Facilities Committees for review prior to District Council consideration. The AR will be sent back to the colleges for this review.
