- <u>Approval of Minutes of March 6, 2017</u> It was moved by Mr. Hardash, seconded by Ms. Chitlik and carried unanimously to approve the minutes of the March 6, 2017 meeting with corrections as noted.
- 2. April 12, 2017 Board of Trustees Meeting

District and campus review is taking place in support of this effort.
