### State/District Budget Update-Peter Hardash

- LAO California's Fiscal Outlook Report: 2012-2013 Budget
  - Proposition 98 forecast minimum funding guarantee increases by \$4 billion in 2012-2013
  - Unlikely legislature will fund with continuing state structural deficit
  - Legislature and Governor will need to address a \$12.8 billion deficit by the 2012-2013 budget plan
  - o 2012-2013 deficit assumes trigger cuts continue into future years
  - By the end of 2011-12, it is projected the State will be \$3.7 billion short of the \$4 billion target
  - Both trigger reductions would likely be implemented
- Governor proposing tax increase initiatives for November 2012 ballot
- Orange County Property Tax
  - Orange Board of Supervisors are withholding, from K-14 education, \$73.5 million in property tax funds
  - \$12 -\$14 million loss of property tax revenue for the 3 community college districts, Coast, North Orange and Rancho Santiago Community College Districts
  - \$2-\$3 million loss for RSCCD (NO STATE BACKFILL)
  - Basic aid districts are currently not affected
- RSCCD Budget Forums
  - District Office-December 1, 2011
  - Santiago Canyon College- December 6, 2011
