

# Transportation Usage in Orange County and the Rancho Santiago Community College District U.S. Census 2000

April 2004

#### **Introduction**

Almost 25% of Orange County adult workers commuted to work by means other than "driving alone". Carpooling (13%), using public transportation (3%), motorcycling, bicycling or walking (4%), or working at home (4%) are important alternative transportation modes for adult workers in Orange County. These alternative transportation modes were reported to be used by 56,245 (38%) adult workers living in the SAC service area. This figure was 21% in the SCC service area.

### **Carpooling**

The use of carpooling and ride-sharing is also high in the SAC service area, and accounts for 23% of all worker transportation. The SAC service area carpooling rate is almost double that of the SCC service area (12%) and county-wide (13%).



## **Public Transportation Usage**

Most adult workers (90%), living in Orange County using public transportation, use the bus system. The bus system was used by 8% of all workers in the SAC service area, 2% in the SCC service area, and 3% county-wide. Relative to other areas of Orange County, use of public transportation is high in Santa Ana, especially in the areas of low household income and high population density just south and west of the I-5 Freeway. Of all Orange County adult workers using the bus system, 35% live in Santa Ana.



## Conclusion

A large number of workers in the Santa Ana area use alternative transportation, including public transportation. The extension of a light-rail system to SAC will improve access to the SAC campus for many students and reduce on-campus parking demands. And, as a "destination" on the light rail system, SAC would be favorably located to assume an even more important position in the future development of the central Orange County area.
