# Rancho Santiago Community College District Reading Course Level Advisement and Placement 

(CTEP-tested Spring 2007 thru Spring 2009)
November 2009

## Needs Form Advisement by Counselor:

From January 2007 to June 2009, Needs Forms were completed for 10,440 students who were administered the CTEP Reading Placement Test at RSCCD colleges. Although curriculum changes in 2008 resulted in new courses, Reading 097 and 102; cut-scores for these courses correspond to those used previously for Reading 095 and the four advisement levels are used here in summary. Of students for whom Needs Forms were completed by counselors:
$>39 \%$ were advised to enroll in Reading 100. A similar proportion of students tested during that period of time were recommended to Reading N80 or 096 (34\%).
$>27 \%$ of students tested were advised to take Reading N90, 097, 095, or 102.
