MINUTES

1.0 PROCEDURAL MATTERS

1.1 Call to Order

The meeting was called to order at 5:17 p.m. by Ms. Claudia Alvarez. Other member present: Mr. Phillip Yarbrough. Ms. Nelida Mendoza arrived at the time noted.

1.4 Approval of Minutes

The committee reviewed the internal and external processes for addressing safety incidents/crisis management presented by staff. After discussion, the committee indicated it was pleased with how the alleged assault was handled but asked that communications with the board occur in a timely manner; preferably before board members hear about it in the media. Ms. Alvarez asked for a follow-up report on timely communications to the board to be provided at the next Board Safety and Security Committee meeting. (For the record: Alleged sexual assault occurred on Feb. 14, 2019; was reported on July 12, 2019, with little details on respondent; and respondent was arrested on September 23, 2019.)

The committee asked Dr. Lamb to check on a schedule for Middle College High School (MCHS) students. The chancellor indicated that the college and district should be able to know where the MCHS students are at all times and he plans to contact the Santa Ana Unified School District (SAUSD) Superintendent to address this concern.

The committee indicated the board doesn't need to know about every crime committed on campus, but a protocol regarding the types of crimes reported to the chancellor and in turn, reported to the board right away, should be established and any sexual assault on a minor should be included in this protocol.

Ms. Alvarez asked if there was anything the board needed to do to improve its policies. Mr. Martinez indicated that he plans to review the board policies and discuss with Mr. John Hanna if there is a need to update any board policies.

Ms. Alvarez asked that the Memo of Understandings with SAUSD be reviewed to ensure the district is protected.

2.2 <u>Discussion of Rancho Santiago Community College District, Santa Ana Unified School District (SAUSD) and Orange Unified School District Joint Communications and Joint Safety Plans on Incidents Impacting Joint Constituencies; and Prevention Efforts</u>

The committee discussed this item during Item 2.1. Ms. Mendoza asked that a joint meeting occur with SAUSD Board of Directors and RSCCD Board of Trustees to discuss safety plans and prevention efforts.

2.3 Update on Administration of Justice/Criminal Justice Degree Pathway

Dr. Lamb provided an update on the Administration of Justice/Criminal Justice degree pathway. Committee members received clarification on data from Dr. Lamb.

2.4 Update on Implementation Plan of Public Safety Task Force Security Recommendations

Mr. Toledo provided an update on the implementation plan of Public Safety Task Force security recommendations.

2.5 Review on Progress of Training of Officers and Campus Personnel Training

Mr. Hardash and Mr. Toledo provided the progress of training of officers and campus personnel training.

2.6 <u>Update on Installation and Completion Timeline of New Safety Emergency Phones</u> District-wide

Mr. Toledo provided an update on the installation and completion timeline of new safety emergency phones district-wide.

2.7 Review of 2019 Annual Campus Security Report (Clery Act)

The committee reviewed an overview of the annual campus security report and received clarification on the data from Mr. Hardash, Ms. Estevez, and Mr. Toledo.

2.8 Proposal of Future Agenda Items

During review of Item 2.1 (Process for Addressing Safety Incidents/Crisis Management), the committee asked that a follow-up report on timely communications be provided at the next Board Safety & Security Committee meeting.
