Ms. Melendez noted this effort will start at the Child Development Centers since food is prepared there.

Ms. Satele noted SCC had a successful Earth Week and Earth Day event was enjoyed by the students. The event will be even bigger next year and be combined with Community Science Night on Friday.

Mr. Barragan noted it was an incredible event and there was a huge turnout and shared photos from the event.

Mr. Kennedy noted SAC's Sustain-A-Palooza was a really nice event and the waste hauler provided great information about the District's recycling efforts. Mr. Kennedy shared Ms. Garcia's report on the event.

Mr. Curiel noted the Earth Day Survey is posted on the Sustainability RSCCD Committee web page.

Ms. Matsumoto asked the Vice Presidents of Administrative Services to share this survey with the colleges and students.
