07/14/22	Last day for any AUX journal entries affecting County Funds to be reviewed, approved, and posted. AUX journal entries <u>not</u> affecting County Funds can be submitted through 08/09/22.	Accounting
07/19/22	Last day for departments to submit 21/22 budget changes to cover negative balances. Budget changes must be completely approved by NOON.	Budget
07/26/22	Accounting Department will send an email confirmation to all special project accountants, program staff, and Resource Development confirming that all year-end accounting entries for special projects (Fund 12, 33, 74) have posted.	Accounting
