Prevailing Wages: This is a public work project. Each Contractor bidding on this Project and all Subcontractors performing any portion of the work on the Project must register with the California Department of Industrial Relations (DIR) and be qualified to perform public work pursuant to Labor Code section 1725.5 throughout the duration of the Project. The awarded bidder shall be solely responsible for ensuring compliance with all provisions of the Labor Code, including section 1725.5 as well as any requirement implemented by DIR applicable to Contractor's services or their subcontractors throughout the Project.
