

## NOTICE INVITING INFORMAL BIDS

NOTICE IS HEREBY GIVEN that the Rancho Santiago Community College District (RSCCD) of Orange County, California, acting by and through its Board of Trustees (“District”), will accept sealed Bids for award of a Contract for **Bid #1325 U Portables Certification Plumbing at Santiago Canyon College**.

The Project requires the following license C-36. The Project duration is 65 calendar days.

Mandatory Job Walk and Pre-Bid Conference: **9 AM on Tuesday, May 30, 2017** at Santiago Canyon College, located at 8045 East Chapman Avenue, Orange, CA 92869 (enter from Chapman Avenue, meet at the flagpole in front of the Admission Building (E)). Any Contractor bidding on the Project who fails to arrive on time and attend the entire mandatory job walk and conference will be deemed a non-responsive Bidder and will have their Bid returned unopened.

**Bids are due at 2 PM on 6/12/17** at RSCCD Facility Planning Dept., 2323 North Broadway, Rm 112, Santa Ana, CA 92706. Submittals received after this time and date will not be accepted. District shall not be responsible for any errors in delivery by the carrier to the wrong location.

**CUPCCAA:** This Project is being let in accordance with the California Uniform Public Construction Cost Accounting Act (“CUPCCAA”) set forth in Public Contract Code section 22000 et seq. Bidders shall comply with any requirements set forth in the CUPCCAA including all guidelines and requirements in the current California Uniform Construction Cost Accounting Commission Cost Accounting Policies and Procedures Manual.

**RSCCD Contractors List 2017:** Bids will not be accepted if a Contractor has not been added to the RSCCD Contractors List for the Calendar Year 2017. Interested Contractors must complete and submit the [Contractor Letter of Interest](#). Form and submit to Rancho Santiago Community College District **prior to 5 PM on 5/29/17**.

**Prevailing Wages:** This is a public work project. The Contractor and all Subcontractors (of any tier) must be currently registered and qualified to perform public work in accordance with Labor Code section 1725.5. Unless specifically exempted by the Labor Commissioner for this Project, the Contractor and all Subcontractors shall furnish certified payroll records as required pursuant Labor Code section 1776 directly to the Labor Commissioner in accordance with Labor Code section 1771.4 on at least on a monthly basis (or more frequently if required by the District or the Labor Commissioner) and in a format prescribed by the Labor Commissioner. Unless specifically exempted by the Labor Commissioner for this Project, monitoring and enforcement of the prevailing wage laws and related requirements will be performed by the Labor Commissioner/ Department of Labor Standards Enforcement (DLSE).
