Project specific Payment and Performance Bonds as well as Insurance Documents & Endorsements are not required until issuance of an award letter.

2. The District has received inquiries about the engineers estimate. The engineers overall estimate is \$1,105,449 for all three projects:

District Operations Center Interior- \$151,081
Santiago Canyon College Interior Lights- \$637,500
Santiago Canyon College Exterior Lights- \$308,868

This is only an estimate and we expect the final proposal budget to be different given the competitive nature of the RFP.
