RE: **AB 1732-Conversion of Single User Restrooms into Unisex/All Gender Restrooms Effective March 1, 2017**

This Facilities Advisory is being issued to all sites to inform you that effective March 1, 2017 single user/occupancy restrooms will be changed to all gender/unisex restrooms. On September 29, 2016, the State Governor signed into law AB 1732 to create Health and Safety Code Section 118600, relating to the identification of single-user toilet facilities as all-gender toilet facilities. This new law is to be operative and effective on March 1, 2017 and requires public educational entities to make available single-user toilet facilities as identified as all-gender toilet facilities by signage and designated for use by no more than one occupant at a time or for family or assisted use, with a locking mechanism controlled by the user. Our office has conducted a site walk, assessment and inventory of every single user/occupancy restroom at your site.

Please note that not all buildings have single user/occupancy restrooms. After review of each building and the restrooms, the restrooms noted below in this Advisory will be changed to an all gender restroom. In some cases, this means that staff single user occupancy restrooms will be changed to an all gender restroom and it will no longer be designated for staff use only. Additionally, some of the currently designated women and/or men single user restrooms will be changed to an all gender restroom.

The restrooms will include new standardized Title 24 (California Code of Regulations) compliant signage and door hardware as needed. Signage and door hardware changes to such restrooms will be occurring over the next several weeks upon receipt of signs and door hardware. Samples of what the signs and door hardware will look like are attached herein.

Please share this Advisory with appropriate staff and/or other constituents as needed to inform them of the changes to the single user restrooms.

The following Single User/Occupancy Restrooms are to be changed to All Gender/Unisex Restrooms, in some cases some of the noted restrooms below are already unisex and need minor sign or door hardware changes:
