## Orange County SBDC Celebrates 20<sup>th</sup> Anniversary on June 22 at RSCCD

(Santa Ana)—Since its "birth" in 1991, the Orange County Small Business Development Center (SBDC) has focused on one thing only---growing Orange County's economy one small business at a time. When the Orange County SBDC first opened, it resided in a small corner of the Santa Ana College library and had one part-time consultant. Today this economic development program of Rancho Santiago Community College District (RSCCD) occupies a suite of offices on the second floor of 2323 N. Broadway in Santa Ana. The Orange County SBDC now employs a full-time director and associate director, 10 business consultants, plus two full-time support personnel.

"The Orange County Small Business Development Center (SBDC) is an integral part of the Rancho Santiago Community College District. Through the SBDC, our district is able to provide a range of services to small businesses and fledgling entrepreneurs in Orange County and beyond. Everyone in the district is proud of the many accomplishments and continued progress and expansion of the Orange County SBDC," says Raúl Rodríguez, Ph.D., RSCCD chancellor.

The Orange County SBDC has a lot to celebrate, including:

- Opening its first satellite center serving the business communities of North Orange County and hosted by the Brea Chamber of Commerce;
- The formation of the Supplier Development Council by the Orange County SBDC in late 2010 to assist corporations and government agencies meet their goals of contracting with small and minority-owned businesses;
- In 2006, 2008, and 2010, the Orange County SBDC was the recipient of the technical assistance grant from Wells Fargo Foundation supporting outreach to and business support services the Vietnamese small business community;

- In 2010, Wells Fargo provided a grant so Orange County SBDC could increase its support of the Hispanic small business community;
- For the past three years, the Orange County SBDC has been a strong partner in delivering assistance to young entrepreneurs though RSCCD's the Youth Entrepreneurship Program (YEP); and
- Since 2001, Since 2001, the Orange County SBDC has helped create 218 new businesses, 1,701.5 new jobs, helped retain 1,025 jobs, helped increase sales countywide by more than \$92.6 million, helped its clients access \$51.7 million in business capital, counseled 6,673 clients, provided 41,187 hours of business counseling, and training for 23,247 small business owners.

"Since its inception, the Orange County SBDC has positively impacted the lives of thousands of current and prospective small business owners in Orange County. At a time when grant funding has been particularly tight, we're pleased to see our partners at the Orange County SBDC not only reach this important milestone, but to reach it and expand to additional locations and add new services,' says J.
