PROJECT UPDATE SANTA ANA COLLEGE DUNLAP HALL RENOVATION

Project Summary:

- Renovate and replace the aging guard rails around the pedestrian walkways on all levels of Dunlap Hall, as well as, providing a new elevator and stair tower.
- Remodel the existing restrooms.

Current Status:

- Construction began in April 2014 with a target completion expected at the end of September 2015.
- Current activities include installation of stainless steel guardrails on all decks, ceramic tile in restrooms, and exterior painting.
- Upcoming activities include concrete section for monumental stairs, installation of guardrail panels, and interior painting of existing building.
- This project is delayed due to delays on fabrication of structural steel and discovery of unforeseen roof leaks.
- The roof will need to be replaced following the renovation of work and completed under another contract for work.
- ► Target re-occupancy Spring semester 2016.

PROJECT UPDATE SANTA ANA COLLEGE CENTRAL PLANT AND INFRASTRUCTURE

Project Summary:

- Construction of a new Central Plant Building.
- Phase I: utility replacement, Phase 2: central plant and Phase 3: mechanical upgrades to 8 buildings and includes a new central cooling plant, underground chilled water piping loop, upgrading existing gas, domestic water lines, sewer, drainage and fire water systems.
- Includes HVAC system conversion for 8 existing buildings to be connected to the new Central Cooling Plant, including a new campus wide energy management system (EMS).
- Includes 10 DSA plan submittals.
- The central plant building will be designed to meet LEED Silver certification.

Budget:

\$68.17 million



Current Status:

- Project is in design.
- Eight plan submittals have been approved by DSA, two more are pending approval.
- New preconstruction consultant, McCarthy, is preparing all work plans, schedules and estimates.

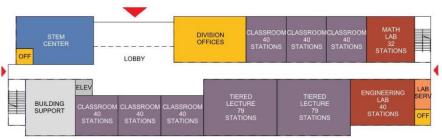

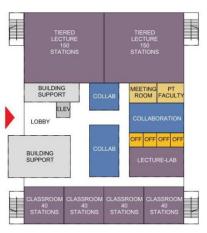

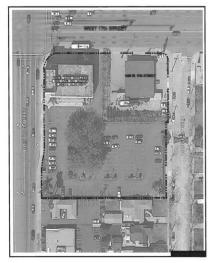

- OEC: Architect completed the programming phase. Pre-construction firm is scheduled for Board approval in February 2015.
- U Portables: Programming phase is ongoing, anticipated completion of design phase is spring to summer 2015.

The following are Measure Q Projects at Santa Ana College:

- Dunlap Hall Renovations: Construction began in April 2014, expected completion in September 2015. Project is delayed due to the delays on fabrication of structural steel and unforeseen roof leaks. The roof will be replaced after the renovation are completed.
- Central Plant and Infrastructure: Project is in design phase, four plan submittals have been approved by DSA, the target construction timeline is July 2015 with completion during the winter of 2017.
- Johnson Center: Project is in program confirmation phase, development of draft program document is underway. Preconstruction firm selection is under review with a target demolition of summer 2016.
- STEM Building: Project is in programming phase, preconstruction firm selection is under review. Demolition target start is August 2016.
- Health Sciences Building: This project has been submitted to the state for future funding, programming to be concurrent with the programming of the STEM project.

- Design and construction start are to be determined. As of right now, there isn't enough funding to complete this project.
- Parking Lot at 17th and Bristol Streets: Project is in the design development phase, design documents to be reviewed by the District prior to submitting them to DSA for approval. In the meantime, the parking lot is being utilized as contractor worker parking for Dunlap Hall.

Active Scheduled Maintenance Projects:

- SAC: Door hardware upgrade; Building H painting and window replacement; Building L roof repairs; Buildings C, N, P and R roof repairs; Parking Lots 1-5 slurry and re-striping and the CEC parking lot slurry and re-striping.
- SCC: Replacement of door hardware, replacement of energy management system, replacement of ac units in CDC and replacement of the main electrical panels in Buildings A, B & C)

Prop 39 Projects:

- Year One SCC: Science Center Building retro-commissioning
- Year One SAC: LED Lighting upgrade
- Year Two SCC: LED Lighting upgrade
- Year Two DO: LED Lighting upgrade

District Office Projects:

 Parking lot resurfacing: Slurry coating and re-striping during the holiday weekend in February. Budget is included in the ADA compliance budget.
